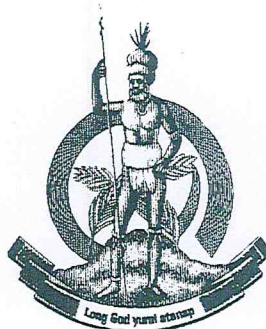

Further Orders Relating To The Supply By Fidelity Communications Corporation Of Certain Wholesale International Internet Capacity

Notice No. 169 of 2017

TRR hereby makes the following Order, based on the findings and reasons in TRR's Second Determination Of Approved Prices For Specific Leased Capacity Amounts Supplied By FCC To Particular Customers.

1. TRR approves the sales by Fidelity Communications Corporation ("FCC") of the additional leased capacity referred to below on the ICL Cable (from Port Vila, Vanuatu to Suva, Fiji) on the condition that the capacity is supplied at a price not greater than the maximum prices set out below and that those maximum prices are applied from the date(s) the additional capacity began to be supplied by FCC:
 - i. For the supply to Digicel of ■ Mbps of additional capacity and a resulting total of ■ Mbps of capacity, under a ■ contract with a remaining term of about ■ years, a maximum price of US\$ ■/Mbps/Month applied to the total capacity of ■ Mbps.
 - ii. For the supply to TVL of a further ■ Mbps, and then a further ■ Mbps of additional capacity and a resulting total of ■ and then ■ Mbps of capacity, on a contract ■ term, a maximum price of US\$ ■/Mbps/Month applied to the total capacity of ■ and then ■ Mbps.

2. FCC is prohibited from supplying the above capacity, other than in compliance with Paragraph 1 above.
